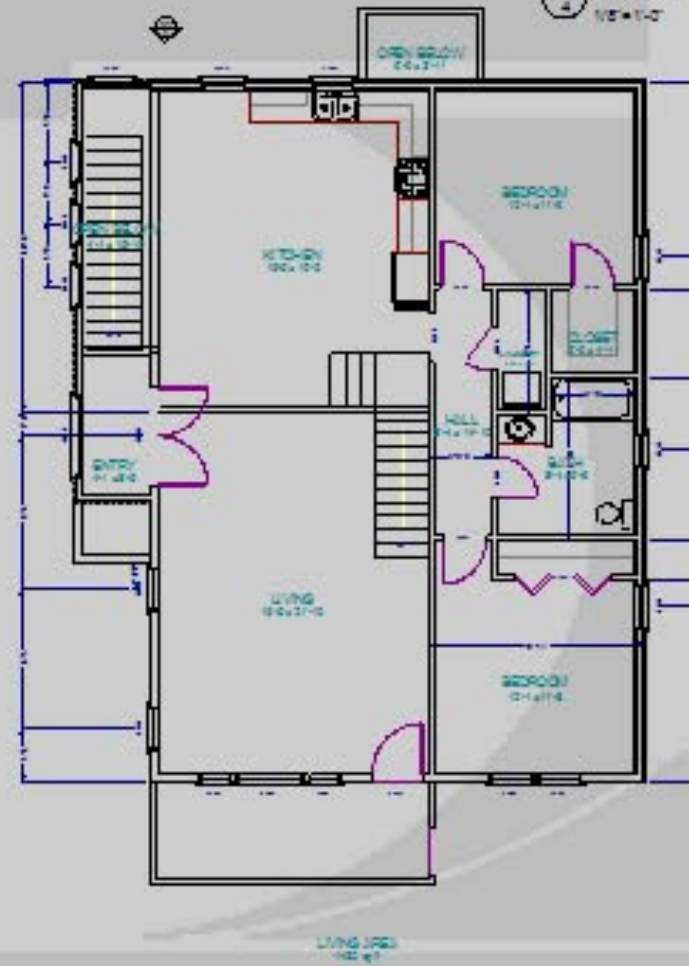

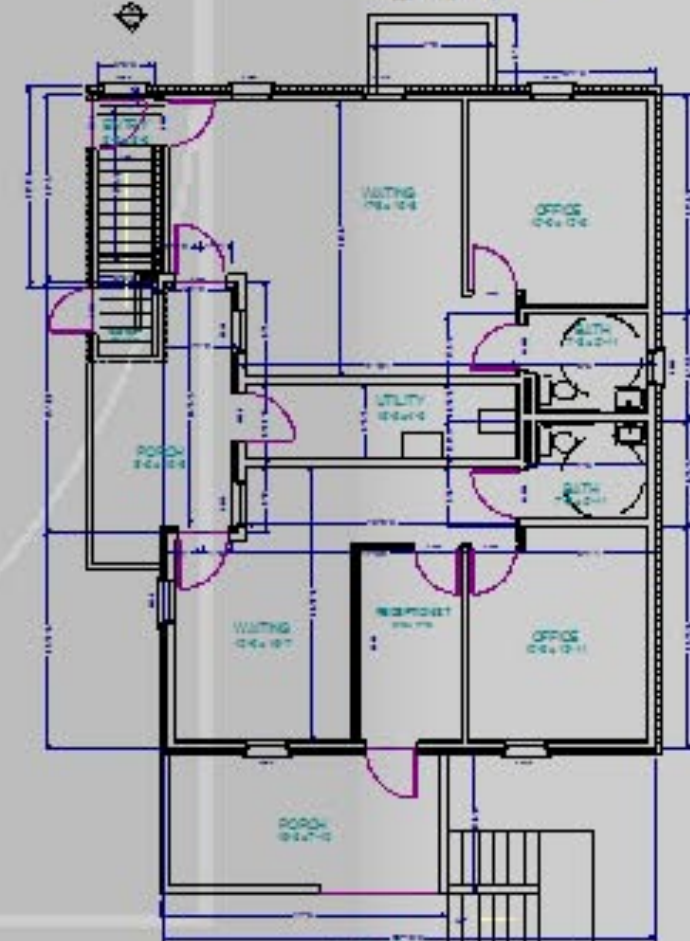
A1 REAR ELEVATION
